Ed Romaine is Brookhaven Town's 70th Supervisor, having been elected to that office during a special election in 2012, and sub-sequentially being re-elected four (4) times with over 59% of the vote.

Romaine has championed environmental and quality-of-life issues throughout his time in public office. Spearheading legislation that will forever protect the Carmans River, which was unanimously approved by the Town Board and embraced by residents, environmentalists, and the building community. He introduced legislation that has strengthened the Town's housing codes and aggressively prosecuted problem landlords that have impacted neighborhoods throughout the Town.

Ed Romaine has reduced millions of dollars in pipeline debt and held the line on total Town property taxes. During his time as Supervisor, the Town received AAA bond rating, saving residents money.

He is a former member of the Suffolk County Legislature, where he was known as a fiscal conservative, sponsoring such cost-saving measures as the Suffolk County Tax Cap. Additionally, he established a record as a fighter for the environment by authoring Suffolk's first Clean Water Act.

Ed preserved countless acres of open space across eastern Brookhaven, the North Fork, and Shelter Island. He sponsored numerous pieces of landmark legislation, including "Michael's Law," which banned explosive fuel gels; the state's first local law to regulate helicopter traffic; and established the LIPA Oversight Commission. In addition, Ed reduced the tax burden on residents by promoting smart government initiatives and real tax reform.

He was elected Suffolk County Clerk and served for 16 years, actively increasing productivity and improving access to official records. Ed is recognized as a pioneer in government use of technology and was chosen "2001 New York State County Clerk of the Year."

Ed began his career in public service as a history teacher in the Hauppauge School District, where he taught for ten years. Ed Romaine earned a Bachelor of History from Adelphi University and a Master's in History from Long Island University.

He resides in Center Moriches with his wife, Diane.

Brooke Lupinacci is a former prosecutor who's dedicated her life to protecting our community. Brooke began her career in public service as an Assistant District Attorney in Suffolk County, prosecuting felons for financial crimes that ripped off families, businesses, and taxpayers. Brooke has achieved justice for victims by securing criminal convictions related to embezzlements, fraud, home improvement scams, welfare fraud and money laundering. Brooke also earned recognition for her work in prosecuting other crimes such as misdemeanor level sex offenses, domestic violence, bias crimes and graffiti cases. No one is more qualified to protect Huntington families and seniors and to fight against pro-criminal policies like cashless bail, which releases dangerous criminals from jail.

Brooke joined the Town of Huntington as an Assistant Town Attorney in 2015. In this role, Brooke combated quality of life violations throughout the Town by enforcing the Town Code, thereby helping to remove eyesores like zombie homes, hoarder properties and squatter houses from our neighborhoods.

Brooke was most recently appointed to serve as Huntington's Director of Labor Relations, where she's trusted to oversee the day-to-day relations between management and the Town's workforce that is largely unionized. To hold employees accountable to taxpayers, Brooke administers, and participates in the negotiation of, the Town's three collective bargaining agreements- including facilitating the resolution of labor disputes and the disposition of employee discipline matters. She manages the Town's recruitment process to ensure that the Town employs qualified individuals in accordance with applicable law.

As our next Councilwoman, Brooke is determined to protect our neighborhoods from urbanization plans that threaten to increase crime, drain emergency services, overcrowd classrooms, and increase taxes. She'll also work to hold the line on property taxes while ensuring the Town of Huntington delivers the highest quality services for all residents. Finally, Brooke will invest in local parks, continue her work to eliminate vacant zombie houses, protect our waterways, and protect our environment.

Brooke earned a Master's degree in journalism from New York University and a Juris Doctor from Touro Law School. A life-long Town of Huntington resident, Brooke and her husband, Stephen, are raising their three sons in Lloyd Harbor.

In 2005, Rob spearheaded efforts to prevent the development of approximately 2,000 units of housing on the former Kings Park State Hospital property. He advocated for and eventually won state support for the transfer of the property to the New York State Office of Parks in 2006. As a former board member of the Nissequogue River State Park Foundation, he helped raise hundreds of thousands of dollars for

beautification and restoration projects, and persuaded the state to begin the first phase of the park's cleanup in 2012-2013. To this day, he continues to volunteer with the Nissequogue River State Park Foundation.

Rob recognizes that our quality of life, which includes safe neighborhoods, great schools, and terrific parks, is the reason why many of us live in Suffolk County. He believes it is incumbent upon elected representatives to protect and preserve these assets for future generations. Therefore, one of his priorities is the preservation of open space throughout his district.

In 2013, Rob ran for the Suffolk County Legislature. He campaigned on serving as a full time legislator in the part time position, and working towards making county government more efficient.

Legislator Trotta was proudly sworn in as the Suffolk County Legislator for the 13th Legislative District on January 2, 2014. He has been re-elected every two years, and started his fifth term in January of 2022.
